Parks and Recreation applied for a \$500,000.00 Colorado the Beautiful Grant from Colorado Parks and Wildlife for funding to support construction of trail improvements on Sand Creek Regional Trail. The grant comes with a match requirement of \$150,000 and those funds are secured through funding allocated previously for the project. This grant funding helps fund the buildout of a hard surface regional trail along Sand Creek Regional Greenway within the City and County of Denver. Sand Creek Regional Trail connects Denver to Commerce City and Aurora providing active transportation and recreation options for metro area residents.
