Amends and intergovernmental agreement (IGA) with Urban Drainage and Flood Control District (UDFCD) by adding \$2,100,000.00 in UDFCD funds and \$0.00 in City funds for a new total agreement amount of \$21,022,032.00 for drainage and flood control improvements along Sanderson Gulch, from Lipan Street to the South Platte River, in Council District 6. No change to previous contract duration (201523631-04). Additional funding from UDFCD for construction activities and post construction vegetation activities. The project will construct flood control improvements along Sanderson Gulch to ultimately remove 94 properties from the floodplain.
