Work will typically consist of timber stand improvement services and vegetation treatment for the purpose of reducing the risk of wildfires and to meet silvicultural objectives. Services are designed to provide for fuels reduction, and timber stand improvement. Services may include the following activities: forest logging, ecological and technical services including vegetation treatment for the purpose of reducing the risk of wildfires and meeting silvicultural objectives for Denver Mountain Parks. This includes furnishing labor, supervision, equipment, transportation, operating supplies (except those designated as Denver- furnished), and incidentals to perform all work necessary. This may include cutting or thinning standing dead or alive and or downed and dead material laying on the ground.
