This is a companion bill request to BR20 0302 which seeks to amend an intergovernmental agreement (IGA) between the City and the Urban Drainage and Flood Control District (UDFCD) by adding \$2,100,000 in UDFCD funds for drainage and flood control improvements along Sanderson Gulch, from Lipan Street to the South Platte River, in Council District 6. The additional \$2.1M brings the total UDFCD contributions to \$2,670,661.21, including the original IGA and all amendments.

Of the \$2,670,661.21 in total UDFCD funds, there is existing budget appropriation for \$1M established in 2017. This companion ordinance requests the additional appropriation for the remaining \$1,670,661.21.
