In an effort to generate additional budget savings to balance our 2020 and 2021 budgets, the Department of Finance Budget and Management Office (BMO) intends to offer a retirement incentive program to civilian employees already eligible to retire under the Denver Employee's Retirement Plan (DERP). For employees willing to vacate their position on or before July 31, 2020, they will receive an up front \$5,000 payout then a benefit equal to one week's salary per years of service to a maximum of \$40,000.
