The proposed ordinance approves the City's issuance of its Multifamily Housing Revenue Notes (Avenida del Sol Project) Series 2020 and the City's utilization of the Private Activity Bond Volume Cap Allocation for the purpose of financing multifamily housing by Gorman & Company, LLC and its affiliates at 5048 Morrison Road. The affordability election related to the Private

Activity Bonds will be at least 4 of the units limited to 30% Area Median Income (AMI), at least 18 of units limited to 40% AMI, at least 37 of the units limited to 60% AMI, and at least 20 of the units limited to 80% AMI. The State of Colorado's Department of Local Affairs has awarded more than sufficient Private Activity Bond Volume Cap Allocation to the City for this project. This ordinance allows for the City's issuance of its Multifamily Housing Revenue Notes (Avenida del Sol Project) Series 2020 and the use of \$15,000,000 of Private Activity Bond Volume Cap Allocation to be applied in 2020 and is consistent with the City Charter, Colorado statutes and the Internal Revenue Code.
