As contemplated in the IGA, during the course of project the City requested construction of several projects to upgrade City sewer and drainage infrastructure in the River North and National Western areas. This amendment provides for the payment of the construction costs and receipt of funds from RTD related to savings it incurred for storm drainage improvements.

This ordinance request seeks to receive \$813,018 from RTD per the North Metro Rail Line Intergovernmental Agreement and appropriates them as follows:
