The hearing for the 1840 Grant Street Urban Redevelopment Plan is anticipated to be October 20, 2020. The general objectives of the 1840 Grant Street Urban Redevelopment Plan are to reduce or eliminate blighted conditions as well as to stimulate the growth and development of the Area by redeveloping the area into an expected mix of uses office, retail and a hotel.
