The purpose of the Denver Health and Hospital Authority (DHHA) contract is for substance use navigation services to increase outreach, harm reduction and treatment support for persons with opioid, methamphetamine and alcohol use disorders. The contracted services include employment of two full-time Substance Use Navigators, one part-time Peer Specialist, the cost of an average of one bed per month, as available, for transitional residential substance use treatment (TRT), and the administration, supervision, support and related expenses for these services.
