Such staffing will primarily be used to provide medical screening for symptoms of COVID-19 upon entry to auxiliary shelter facilities, located at the Denver Coliseum and formerly also including the National Western Complex; as well as additional clinical triage for those guests identified to be displaying concerning symptoms and needing further assessment or referral to testing. This medical screening/triage serves to protect healthy congregate shelter guests from exposure to illness, as well as to serve to connect symptomatic shelter guests to appropriate resources. **Location (if applicable):**
