The agreement is for the City's financial contribution to CDOT's Alameda Phase 2.0 project. The project includes the design and construction of a new/widened Alameda Bridge over the S. Platte River, local street improvements to Lipan St., pedestrian and bicycle facility improvements on the road, and a grade-separated S. Platte River Greenway path. The contribution limits were established in the DRCOG TIP (TIP ID 2020-061) and is limited to \$3,000,000.
