As part of the Project, Arapahoe County has requested from the City access for staging of materials and equipment as well as potential construction work for the Project. The License and Use area owned by the City and is under the authority, management and operation of the Denver Department of Parks and Recreation (DPR) as part of its trail system along the High Line Canal. Arapahoe County will pay the City as compensation for the City granting the License, the sum of Four Thousand Dollars and Zero Cents (\$4,000) for the one-year term of this Agreement. The County has the option to extend the term of the License Agreement for an additional one year upon the payment of an additional \$4,000
