Executive Summary with Rationale and Impact:

This code change is required to bring the Denver Revised Municipal Code into conformance with changes made to state statute in 2019. HB19-1148 set a maximum municipal sentence of 364 days. This builds on previous reform efforts the city has made to address undesirable consequences of code violations. The purpose of this bill and previous Denver reform efforts is to protect against deportation consequence for people otherwise here legally if committing a municipal offense. Changes have already been implemented in practice and this action would simply clean up the code to match state law. Fines would remain unchanged. Nothing in this bill or previous legislation limits alternative sentencing options that are otherwise available to the court
