Summer Scholars provides after school recreation programs. Participants in the Summer Scholars programs are primarily low-income youth who are in need of extra help with reading. Participants typically read below established grade levels, and academic failure in elementary school is an established risk factor for later issues related to juvenile delinquency, teen pregnancy, and substance abuse. A lack of access to recreation services is another risk factor for low-income youth, and Summer Scholars' literacy and recreation programs seek to offset the risk factors of academic failure and lack of access to recreation services. Summer Scholars also provides camp programs and swim lessons to participants. **Location (if applicable):**
