Type and Scope of services to be performed:

This amendment creates a \$3,050,000 contract between the Department of Housing Stability (HOST) and Northeast Denver Housing Center Inc. (NDHC) to administer the Temporary Rental and Utility Assistance (TRUA) Program. This contract adds \$750,000 to the existing contract amount of \$2,300,000 for a total amount of \$3,050,000. This amendment also extends the contract from an existing term of 1/1/2019-12/31/2020 to 1/1/2019-3/31/2021. NDHC will provide housing rental assistance and utility assistance to eligible households in the City and County of Denver. TRUA may provide up to six months of rental assistance and/or up to two payments of utility assistance to Denver households earning up to 80% of the area median income.

This \$3,050,000 contract is expected to serve approximately 1,280 unduplicated households by March 31, 2021.
