Originally established to support improvements to the Colorado Convention Center in 1989, the fund is no longer necessary. The \$2,085,506.55 of remaining cash will be transferred to the Colorado Convention Center Capital Fund (38422) to serve as reserves for future COP payments to protect against volatility of revenue sources. The cash transfer amount may be adjusted pending transactions that may occur before the transfer takes place.
