Type and Scope of services to be performed:

BC Evergreen, LLC provides food and beverage services to golfers and the public at the Evergreen Golf Course clubhouse. The amendment will modify the concessionaire payment terms and extend the term an additional year.

The amendment will modify the concessionaire payment terms to the following due to COVID impacts:

• GAMP for April 1, 2020 through April 1, 2021 shall be waived.

• Percentage of revenue payments will be waived from May 20, 2020 thru April 20, 2021 if the monthly gross revenue is less than 90% of the year over year monthly gross revenue for 2019. If the year over year monthly gross revenue is 90% or greater of the 2019 monthly gross revenue, then the percentage of gross revenue payment for that month will be due according to the requirements in the current agreement.

The amendment will also extend the term one year as a result of waiving 2020 GAMP due to COVID.
