Type and Scope of services to be performed:

This contract amendment provides BWCs for the Police and Sheriff departments. Axon BWCs are fully integrated with Axon Evidence (Evidence.com) which provides unlimited data storage and automatic time synchronization of video footage with immediate upload at device docking. Footage can be shared across agencies.

This amendment incorporates the purchase of Tasers (ECWs) used by Denver Police and Sheriff's Departments. ECWs from Axon have been in use by the City for over a decade and previously were purchased using Purchase Orders. The ECW system can connect directly with Evidence.com. All test and deployment records are automatically downloaded through the docking station. The ECWs can interface with the BCWs.
