Phase 2 work includes construction on Levels 4, 5 & 6. This work includes, but is not limited to:

- Expanding the Level 6 ticketing check-in area in North end of Terminal on Western side only and constructing a new TSA security checkpoint
- Upgrading and modernizing the escalators
- Upgrading HVAC, lighting, and fire alarm systems
- Refreshing all finishes

This amendment would extend the duration of the contract to April 15, 2024, increase the maximum contract amount by \$170 million to \$365 million, and amend the milestones and liquidated damages, including by adding new milestones related to the Phase 2 work. **Location (if applicable):**
