The U.S. Government Lease for Real Property codifies the Federal Aviation Administration's (FAA's) use of approximately 1,400 square feet of warehouse space located in the WorldPort Buildings, operated by Denver International Airport. The FAA's Radio Engineering group is currently upgrading the radio communications equipment at each of the seven radio transmitter sites around Denver International Airport (DEN). The radio equipment is currently stored in the FAA's Technical Operations Center (TOC) located next to the Mt. Elbert satellite parking lot. Due to the COVID-19 pandemic concerns, the FAA is limiting access to the TOC and has asked the FAA Radio Engineering group to relocate its stored radio equipment.
