Approves and provides for the execution of a two-year federal Grant Agreement between the City and County of Denver and the U.S. Office of National Drug Control Policy in the amount of \$824,254 to support initiatives of the Rocky Mountain High Intensity Drug Trafficking Areas (HIDTA) Program. The HIDTA program, created by Congress with the Anti-Drug Abuse Act of 1988, provides assistance to Federal, state, local, and tribal law enforcement agencies operating in areas determined to be critical drug-trafficking regions of the United States. This grant program is administered by the Office of National Drug Control Policy (ONDCP).
