The project will construct medians at roughly a two-block length cadence as well as pedestrian bulbouts at certain locations. Given the cross-section of West Colfax, intersection bulbouts in combination with medians will be constructed on the north side of the street between Sheridan and Raleigh, while bulbouts in combination with medians will be constructed on the south side of the street between Quitman and Irving. Together, these will increase the overall safety of West Colfax by reducing the number of conflicts between turning vehicles and pedestrians, provide a refuge, reduce crossing distance, and provide traffic calming effects. It will also increase the number of pedestrian crossings.
