Type and Scope of services to be performed:

The City and County of Denver extensively uses ESRI's industry-standard ArcGIS products as the core for all map-based information services, including 911, 311, Denvergov.org, planning and development, property taxation, fire station response time analysis, crime analysis, asset management, and addressing. This Enterprise License Agreement lowers the cost-per-unit for GIS software and substantially reduces administrative and procurement expenses.

The software covered under this agreement also enables critical mapping integrations with the following enterprise applications:

- Pocketgov
- Accela
- Workday
- GenTax
- Tyler Tax Collection System (CORE)
- Real Property Application
- Denver Maps (external facing mapping application)
- Map It Denver (internal facing mapping application)
