A five-year agreement in which the City will perform maintenance on signs, stripes, and signals along State Designated Roadways throughout the City and County. The City shall maintain signs and markings at the locations listed above in the description. The City shall maintain all pavement markings. The City shall maintain all regulatory and warning signs that can be mounted on City standard square tubing posts, all delineator posts, and all guide signs installed and owned by the City. The State shall maintain all regulatory and warning signs on CDOT standard tubular posts if too large to be mounted on City standard square tubing posts, all guide signs not installed and owned by the City, and all other signs not maintained by the City.
