The goal of this project is to deploy stop bar and advanced detection at the 56th Avenue intersections to support a traffic adaptive pilot implementation and Automated Traffic Signal Performance Measures (ATSPMs). This project will cover 56th Avenue from Quebec Street to Tower Road. To compare the effectiveness of adaptive to TOD, all 13 signals will be retimed. Signals needing additional pedestrian push buttons and beacons will be added. Note that locations can be added, removed or changed throughout the entirety of the project based on funding and other constraints.
