**Executive Summary with Rationale and Impact:**

The proposed ordinance approves the City's issuance of its Multifamily Housing Revenue Note (The Rose on Colfax Project) Series 2021 (the "Note"). The ordinance also approves the City's utilization of the Private Activity Bond Volume Cap Allocation for the purpose of financing multifamily housing by Mercy Housing Mountain Plains (Mercy) and its affiliates that will be located at 1500 N. Valentia Street and 1510 N. Valentia Street. The affordability election related to the Private Activity Bonds will be 16 units limited to 30% Area Median Income (AMI), 5 units limited to 40% AMI, 10 units limited to 50% AMI, 37 units limited to 60% AMI, and 14 units

limited to 70% AMI. The State of Colorado's Department of Local Affairs has awarded sufficient Private Activity Bond Volume Cap Allocation to the City for this project. This ordinance allows for the City's issuance of its Multifamily Housing Revenue Note (The Rose on Colfax Project) Series 2021 and the use of \$15,425,000 of Private Activity Bond Volume Cap Allocation to be applied in 2021 and is consistent with the City Charter, Colorado statutes and the Internal Revenue Code.
