The purpose of this contract amendment is to continue to engage with The Salvation Army Inc to provide 24-Hour Shelter Operations and Services Support for Congregate Shelter at 48th Avenue Shelter ("48th Avenue Shelter") and Non- Congregate Activated Respite and Protective Action hotel and motel rooms ("Hotel/Motel Sites") for people experiencing homelessness within Denver City and County throughout the current COVID-19 emergency. This amendment would allow the Contractor to provide these services in response to the COVID-19 public health crisis through June 30, 2022 unless otherwise extended.
