The City and RTD agreed in the 2013 North Metro IGA to certain funding obligations to enable the construction within the Denver boundaries and to cooperate with regard to certain infrastructure improvements related to the development of the North Metro Rail Line. The 2013 agreement considered the need for future intergovernmental agreements to address specific issues.

This IGA provides funding for coordination between RTD and the City related to multi-modal transportation connections, including the 48th / Brighton Station, Station Plaza & Pedestrian Bridge, and Marion Underpass at the National Western Center.
