Ordinance Number 84, Series of 2019, established the College Affordability Special Revenue fund, fund number 11871, to administer the program approved by Denver voters in the 2018 election and supported by a 0.08 percentage point increase to the sales tax rate. Since the SRF's establishment, the organization responsible for administration changed its name to Prosperity Denver Fund. This bill request is an administrative action to change the name of the SRF to the Prosperity Denver Fund to align it with the organization's name.
