This fund will be used to strategically deploy priority programs that mitigate displacement in neighborhoods where the City is investing in large capital projects. Community Planning and Development will administer the fund, in collaboration with other City agencies through the City Investment Impact Committee (CIIC), which CPD convened in 2020 with Denver Economic Development and Opportunity's Neighborhood Equity and Stabilization Team.

The revenue to the fund includes appropriated General Fund transfers, with the potential to leverage other revenue sources in future years.

The expending authority of the new fund will be the Executive Director of the Community Planning and Development, and its delegates based on programs approved by the CIIC. The Fund will be revenue-based and non-lapsing.
