Agreement with the City and County of Denver. This agreement stipulates that any proposed fee changes will be submitted to the DPR Manager, with the Manager's recommendation on the proposal, to City Council for consideration and action.

The Four Mile Historic Park is requesting a three dollar (\$3) fee increase for general admission pricing across all levels. The Four Mile Historic Park maintains a commitment to ensuring access for all, through SCFD free days, participation in the 5x5 program, and three free admission events per year.
