This lease term is for approximately 2 years + 1 month at a yearly rental rate of \$10.00.

Catholic Charities is party to Contract No. HOST-202057226-00 ("Service Contract"), pursuant to which Catholic Charities is to operate a shelter for women experiencing homelessness at 4330 E. 48th Avenue. The Lease will be in effect until the earlier of 12/31/2023 or the termination of the Service Contract.
