Type and Scope of services to be performed:

This project currently provides emergency outdoor sheltering and serves individuals currently experiencing homelessness at three managed sites by providing safe outdoor space to socially distance, access to hygiene facilities, and supportive staffing to prevent, prepare for, and respond to COVID-19.

This contract funds at least four SOS sites, with amenities and services that provide outdoor accommodation for 310 households, comprised of approximately 370 individuals. Existing sites are located at Regis University (3333 Regis Blvd.), Denver Health (780 Elati St.) and the Denver Human Services East Office (3815 Steele St.).

This SOS funding assists strategies to prevent the spread of COVID-19 among people experiencing unsheltered homelessness by providing safe space to socially distance, access to hygiene facilities, and supportive staffing.
