The contract with Norris Design, Inc. is for On-Call Landscape Architectural Planning, Design, and Related Services including, but not limited to, assessment, planning, design, and construction observation services related to parks and parks facilities. The amendment will extend the term one additional year. Due to unforeseen delays associated with COVID-19 and extended timelines on projects, utilization of these on-call contracts has been limited. An extension will allow DPR to utilize these on-call consultants for upcoming projects, and also allow DPR adequate time to consider how to best rebid these services.
