The contract with Downtown Denver Events, LLC . is for the public, Ice Skating and a Beer Garden. The amendment will extend the term an additional two years. Extending will enable DDE to continue operations and management of the skating rink and beer garden until the Elevate Denver bond project begins construction in 2024, which was delayed due to the COVID-19 pandemic. Additionally, the ongoing operations of the ice rink and beer garden in Skyline Park will contribute to the City's economic recovery efforts.
