Denver International Airport (DEN) is requesting the creation of one new fund under the airport's existing Fund 73850: Capital Equipment and Improvements Fund. This new fund will allow for DEN to report and track in Workday the 1% contribution of art funds from eligible capital projects as outlined in the Denver Public Art Policy, and the corresponding usage of those funds at DEN. There is a system limitation that is requiring the creation of the new fund. The new fund DEN would like to create, for reporting purposes, will roll-up to the existing Fund 73850, is as follows: 73853- "Airport Capital Art Fund". DEN requests authorization of cash transfers to this new fund from any eligible DEN fund without having to go to an ordinance each time.
