### **Executive Summary with Rationale and Impact:**

Detailed description of the item and why we are doing it. This can be a separate attachment. The purpose of the resolution is to confirm the appointment by DURA of Eric Hiraga to the SDC Board of Directors for a term expiring June 30, 2023.

In 1995 the City and County of Denver ("City") and DURA agreed to create the Stapleton Development Corporation ("SDC") to providing planning and redevelopment services relating to Stapleton, in close cooperation with the City and DURA. The Stapleton Cooperation Agreement between the City and DURA required the Bylaws of SDC to have a Board of Directors with 11 voting members and 5 ex-officio members. Two of the voting members are appointed by DURA and the remaining nine voting members are appointed by the Mayor. All 11 voting members must be confirmed by City Council.

The DURA Board of Commissioners has considered the appointment of Mr. Hiraga to serve on the SDC Board of Directors and approved the appointment via Resolution on January 20, 2022, with a recommendation for Denver City Council confirmation.
