EXECUTIVE SUMMARY

WORKNOW is a job recruitment, advancement and support platform for Denver metro fan directly affected by community construction projects. This is Denver's first workforce development platform that equalizes opportunities for all Coloradans by enabling inclusive, diverse, and skilled employment in construction. WORKNOW programming is concentrated on career navigation, job skills training, job placement, career coaching and advancement, and community building.

The goal of WORKNOW is to create a partnership that supports the development of a local infrastructure construction job opportunities. This partnership believes in the efficiency and effectiveness of collaboration between nonprofit and for-profit organizations; government and non-government organizations; community and faith-based organizations; business; education in developing a quality workforce sustainable neighborhoods.

Launched in 2017, WORKNOW exists to coordinate and train on infrastructure projects to provide access for local residents and to provide project contractors of local workers in craft and professional service positions.

As a co-founder of WORKNOW, City & County of Denver is one of the Colorado Resource Partners an alliance organization with partner funds and leveraged WORKNOW was launched through existing infrastructure of the Community College of Denver's Center for Workforce Development.

- Foster demand driven skills attainment and employment using regional infrastructure projects
- Enable upward mobility for all metro Denver residents and families
- Align and integrate programs and services and promote exchange of best practices and technical resources

WORKNOW is progressing well with measurable outcomes. Through the partnership and investments of other funding partners, as of December 2021, WORKNOW has engaged 2,638 members, up from 1,300 in the previous year. Of those, 47% (56%) have completed a training and secured industry employment. WORKNOW members have secured new employment. WORKNOW has assisted 47 apprentices secure placement in the Registered Apprenticeship Program recognized by the U.S. Department of Labor. 32% of WORKNOW members come from priority zip codes.

In all, the city is allocating \$1.2 million to the Construction Career Pilot. The 2022 Denver Construction Career Program staff team within DEDO/Denver Workforce Services is implementing the program.
