### Type and Scope of services to be performed:

This contract engages Denver Public Schools (DPS) as the city's youth provider of the Summer Youth Employment Program (SYEP) for the 2022 summer season. The program's goal for service in 2022 is 194 youth. Each youth will have the opportunity to work 120 hours earning at least the minimum wage.

Since June 2016, when Denver began its new contracted delivery system for adult and youth workforce programs, DPS has demonstrated success related to youth enrollments and service. In addition to the In-School Youth program under WIOA, Denver's Summer Youth Employment Program was also added to DPS' contract beginning for Summer 2018, was performed in Summer 2019, 2020, 2021 and will be continued for 2022 with this contract.

DPS' Family and Community Engagement (FACE) team worked with DEDO to reconfigure the SYEP program to be able to deliver pre-employment training and career exploration content in a return to a more traditional delivery of services through 120 hours of paid work experience.

Program focus is on low-income youth and, given that there are more such youth interested in this program than our budget can accommodate, the qualified eligible applicants are being offered a chance to participate through a defined selection process.
