In 2017, DEN signed contracts with HNTB Corp (HNTB) and Jacobs Engineering to provide architectural and engineering design services relating to DEN's Concourse Expansion Program. In June 2020, the HNTB Contract was amended to accommodate additional project requirements associated with Phase 2 work.

This second amendment to the HNTB Contract, in the amount of \$14M will increase capacity to accommodate additional design work needed for the following:

- Concourse Gate Apron Rehab (GARDI)
- A-East Ground Load Expansion

This amendment to the HNTB Contract will increase contract capacity to accommodate the additional project requirements and meet aggressive schedules.
