This includes providing an appropriate level of care based on clinical assessment, integrated with a flexible array of housing options delivered through an evidence-based Housing First approach to provide housing and supportive services for the costliest members of the "Super Utilizers" population. CCH will provide housing services, supportive services, case management, treatment options, and complete stipulated data reporting.
