Type and Scope of services to be performed: This resolution request is a zero-dollar purchase agreement for thirteen (13) Freightliner tandem plows (cab and chassis) and two (2) Freightliner street sweepers (cab and chassis) to support DOTI's Street Maintenance Division and four (4) Freightliner trash tractors to support DOTI's Solid Waste Division. To finance this and seven other zero-dollar purchase agreements, there is a capital lease agreement being submitted simultaneously. The total cost of all equipment under this zero-dollar purchase agreement with Trans-West will be \$2,471,033.
