Denver believes its proposed reissuance of the grantee authority and administrator role to the World Trade Center Denver (WTCD) would be in the public's interest. The administrator role includes operating, maintaining, and administering FTZ project requests under the federal laws and regulations, including the guidelines enforced by U.S. Customs & Border Protection (CBP). The administrator coordinates the application and approval process with the national FTZ Board, including the creation and execution of operator and site agreements. This role also requires that the grantee authority remain accessible to respond to inquiries or issues raised by CBP or others.
