PROJECT shall include construction by CITY of the drainage and flood control improvements as set forth in the final design and vegetation establishment. PROJECT elements include storm improvements including pipe and storm inlets. Agreement No. 21-05.14A: This agreement will commit an additional \$1,000,000 in Mile High Flood District (UDFCD) funds, and \$1,000,000 in Wastewater Enterprise funds for the Marston Lakes North at Bowles Ditch Project to construct drainage and flood control improvements for a total of \$2,000,000. The improvements will include drainage improvements for Marston Lake North at Bowles Ditch in southwest Denver. This project is being managed through design by the MHFD (UDFCD) and will be constructed by CCD. The city shall be reimbursed the MHFD funds after construction.
