The contract contains additional Scope Options, including but not limited to four potential baggage handling system terminal projects for which DEN has sought grant funding under the Federal Aviation Administration's (FAA) Notice of Funding Opportunity for the Bipartisan Infrastructure Law, Airport Terminal, and Tower Project Information Submittal. Work Scopes will be issued as funds become available; the contract will not exceed \$500,000,000.
