Provide and manage Safe Outdoor Space for people experiencing homelessness in accordance with its existing contract with HOST.

Colorado Village Collaborative ("CVC") provides shelter and services for Denver's unhoused population. The existing license allows CVC to operate a Safe Outdoor Space campsite at 3815 N Steele Street, adjacent to the East Side Denver Human Service building for a one-year term expiring 12/9/2022. The existing license has a provision for the City to elect to extend the license for two 6-month periods.

This amendment exercises the City's options, extending the agreement for 12 months to 12/9/2023.

In addition, this license expands the size of the site.
