These funds provided to Brothers Redevelopment, Inc. are being utilized for the administration of the Temporary Rental Emergency and Utility Assistance (TRUA) Program. Brothers Redevelopment will provide emergency housing rental assistance and utility assistance to eligible households in the City and County of Denver. The program is designed to help residents avoid an eviction and maintain housing stability by assisting low- and moderate-income residents (80% area median income and below) who are experiencing a housing crisis due to a financial hardship. This amendment will allow an additional 400 households to be served through the duration of this program; for a new total of 1,160 households served.
