This request is for an amendment between Oak Leaf Solar 56 LLC (Oak Leaf) and Denver International Airport (DEN) to correct typographical error in the calculation of the annual License Fee that was contained in the original agreement. The License Fee for non-exclusive access to the Land used for the Operator's Facilities should be Twenty-Five Hundred Dollars (\$2,500.00) per year, with a Two Percent (2%) annual escalation each January 1 of the Term. The contract budget was based upon the correct fee and will not be changed.
