This Agreement is intended to provide the Terms and Conditions for the City to, from time to time, interconnect and operate City owned Photovoltaic (PV) Solar, Battery Storage, and other Distributed Energy Resource (DER) Systems in parallel with the Xcel electric distribution system. This Agreement supports the City and Xcel's mutual goals of increasing distributed renewable energy production by reducing the administrative burdens associated with interconnection, but it does not commit funding to any specific DER project.
