Executive Summary with Rationale and Impact:

Detailed description of the item and why we are doing it. This can be a separate attachment. The amendment to DRMC Chapter 59-2 would allow a Temporary Managed Community as a temporary use by zoning permit in all zone districts in the former chapter 59, subject to all applicable limitations, definitions, and procedures of the Denver Zoning Code regarding a Temporary Managed Community use. An associated amendment would update the Denver Zoning Code Section 11.11.17 pertaining to Temporary Tiny Home Villages, renaming the section to Temporary Managed Community and updating the associated regulations; rename and revise the existing definition of Temporary Tiny Home Village; update the use tables in Articles 3-9 (Neighborhood Contexts) to reflect this renamed use; and make minor edits to Articles 10 and 12. Councilmembers Robin Kniech and Chris Hinds are sponsoring these amendments.

We request an effective date of June 12, 2023 for this amendment. We also request that this text amendment precede the proposed text amendment for ADUs in Denver that will be submitted at approximately the same time as this request (i.e., this amendment would receive a bill number earlier than ADUs).
